


CCT System Development Philosophy!

How do we preserve documents and combat the possibility of its counterfeit?

A simple way to describe CCT system and its AC-QR product is by how the genetic system works in producing a very specific and unique DNA code for each. The DNA, a detailed genetic information map and storage, is considered the only unique identifier as it is not replicated and any change in its components will result in a clearly indicated change in the outcome.

CCT system considers each document and product an individual item; the system gives it at its creation a unique (AC-QR) code that stores its information. The code is unique and not replicable; in addition, at any point of time a change occurs to the document or product it is detected by CCT system with real time online verification and authentication process, with the ability to trace and track authentic document changes.

What does **CCT** Pharma do?

1- Protect pharmaceutical drugs identity from counterfeit or fraud utilizing a combination of Block Chain, Anti-counterfeit QR and Cloud computing Technologies to perform online real-time verification with 100% accuracy.

CCT system creates a unique AC-QR code labeled on the drug in which all information are preserved as meta-data and pdf forms, easily and confidentially retrievable real-time online from protected servers or cloud system.

- 2- Traceability of drugs from its point of origin to every point of use real-time on-line from any where worldwide based on authorized access.
- 3- Tractability of any changes over the age of the item after its initial production such as whereabouts, expiration, recall etc. all real-time online.
- 4- Full control and edibility of the item from owner without loss of history such as the ability to edit the information, temporary halt it or completely nullifying it.
- 5- Retrieval of item current custody and ability to update it online.
- 6- Verification of item's originating organization online real-time.
- 7- Highly secured archiving of database in computing cloud with real-time online retrieval.
- 8- Statistical data analysis for products and its where about.





Two simple stages:

Stage 1 is document production with encoded information


Stage 2 is real-time online verification

Stage1: Production

CCT- Medical program uploaded on clients item (drug package, box etc.) server, CCT-Pharma gets to work behind the scene as client request document production, it automatically generates encoded AC-QR code with the programed information. Once the item is printed it securely uploads the original static information to client server/cloud with both meta-data and scan of the original document.

Stage 2: Retrieval & Verification

Anytime anywhere worldwide when needed to authenticate and verify encoded item, the end-user - per authorization level - will simply utilize CCT special iVerify application to scan the coded AC-QR item with instant online real-time results. Verification and Authentication are instant, with most updated changes if any.
